Course designer Robert Trent Jones Jr. describes Joondalup as unquestionably one of the world's finest golfing experiences and anyone who has taken on his superb creation will be hard pressed to disagree. Our course is built on a hilly site, part of which was a disused limestone quarry. The course is routed past and over rocky ravines, bordered by lush bush land and affording frequent sweeping vistas of the surrounding countryside and suburbs.

Three nine-hole loops play away from the Clubhouse and are aptly named the Lakes, Quarry and Dunes nines respectively, While the Quarry Nine provides the most spectacular experience with some breathtaking quarry carries, the Lakes and Dunes are equally enticing. From some of the higher points on the Lakes Nine, golfers are treated to views of the Sunset Coast and the Indian Ocean. Our Resort has won many accolades over the years and has been rated Australia's # 1 Resort Golf Course 2003/4, 2005/06 and again in 2007/08 (*Golf Australia Magazine*).

As a Member you have access to our Club House which has first-class restaurant facilities that caters for Members' social and competition needs, and is also available as a function venue for corporate or public events. Members of our prestigious Country Club are entitled to golfing rights at our 27-hole Championship Course, which is rated amongst one of the best in the world, and the use of our facilities and services at our Resort. Members are also eligible to discounts on purchases for most items at the Pro Shop, Cafe 28, the Country Club Restaurant and the Bistro 38 at the Joondalup Resort Hotel. 7, 6½ & 6 Day Members receive a Members Guest pass which entitles them to bring ten (10) Guests outside of competitions at the special Member's Guest rate green fee of \$40.00 for 18 holes per annum. 5 Day members also receive a pass which entitles them to bring five (5) guests also at the special Members Guest rate green fee of \$40.00 for 18 holes, also outside of competitions, per annum.

Annual subscription fees apply to all categories and a compulsory House levy applies to those with playing rights. These fees will be charged from the date of settlement. The current annual subscription fees are enclosed for your information.

Our Club has entered into a number of exclusive Reciprocal arrangements with other prestigious Clubs, also entitling our Members the use of their courses and their club facilities at a discount rate. A list of these Reciprocal/Affiliated Clubs will be made available upon gaining Membership.

Corporate Membership at Joondalup Country Club is a Non Transferable Membership (Term Membership) which expires on the 30th June 2027. Corporate Membership offers membership to a minimum of 2 nominees and a maximum of 4 nominees.

The nomination fee for 2 nominees is \$20,000.00 and \$5,000.00 for each nominee thereafter.

Please refer to the list below for the categories which are available and the current annual subscriptions.

Guidelines for Corporate Membership are:

- Nominees must be employees of the registered Company
- Each nominee receives playing rights and pays the relevant annual subscription fee
- Compulsory House Levy and Golfer's Insurance applies for each nominee
- Price structure as above Non Transferable Membership table depending on category
- A Transfer Fee of \$US550.00 applies to transfer nominees

Added benefits for Corporate Membership are that upon joining and paying the relevant nomination fee, the Company receives the following:
